According to a recent report from Fitch Ratings, Emerging Asia is expected to expand 6.8% in 2012.¹ Meanwhile, David Rosenberg, chief economist and strategist for Gluskin Sheff & Associates, says that the U.S. faces even greater challenges this year, projecting growth of 1.5-1.75% in 2012.² At the same time, the European Commission lowered its expectations of Europe, which is now expected to achieve only 0.8% growth this year.³

"Asia remains a very attractive market. The economy continues to grow and there's still ample opportunity for businesses willing to pull the trigger, as Sun Tzu would say. We make that decision easier for companies by serving as their back-office here in Asia, supporting every need from hiring and staff management to payroll and reporting.
